GIRLS INC. NATIONAL PROGRAMS

Girls Inc. offers excellent research-based programs that are designed specifically for girls. All programs are age appropriate and designed around the developmental capabilities for the given education and prevention area. Girls Inc. of Wayne County implements several of these programs.

Allies in Action This anti-bullying program teaches girls learn how to be allies and treat others with respect.

Economic Literacy is a finance-based program designed to teach girls about money, entrepreneurialism, investments and banking.

Friendly PEERsuasion In this peer-education program, girls ages develop skills to resist pressure to use harmful substances and learn healthy ways to manage stress and confront peer, media, and other pressures.

Leadership and Community Action Girls build their leadership skills and create lasting social change through community action projects.

Media Literacy Girls increase their awareness of the scope and power of the media and the effects of media messages on girls and women. They learn to analyze critically what they see and hear in the media, advocate for change in entertainment, news, and advertising media, and create images that are more realistic and reflective of their lives.

Healthy Sexuality Girls learn about and develop an appreciation for the human body and all it can do, engage in healthy relationships, be inclusive and supportive of diversity and rights, explore values, and think about their futures and the world around them.

Operation SMART is a program designed to encourage girls to explore science and math in creative ways. It focuses on equity, exploration, empowerment, and fun.

Sporting Chance Girls learn to appreciate an active lifestyle as they develop movement and athletic skills, cooperative and competitive spirit, health awareness, and interest in sports and adventure. Girls also explore career opportunities related to sports and experience the benefits and excitement of taking healthy risks.

Healthy Living This program teaches girls how to live their healthiest lives through healthy food and nutrition, movement and exercise, and supporting positive mental health.

SERVICES:

Our services include on-site after-school and summer programming as well as off-site outreach programming in our local school systems. We strive to be a resource in our community for girl-related issues and are always available to assist families, girls and organizations in navigating those issues.

AFTERSCHOOL MEMBERSHIP

\$15/month (\$10/month with autopay)



- Girls currently enrolled in K 10th Grade
- Transportation provided from RCS to Girls Inc. with completed T-10 form.
- Cost of membership includes snack, daily activities, and field trips.

SUMMER MEMBERSHIP

\$75/week (\$50 Sibling Rate/week)

- Girls going into K 10th Grade in the fall
- Hours of Operation: 7:30 am 5:30 pm
- Cost of membership includes breakfast, lunch, snacks, daily activities, and field trips.
- Age appropriate activities and program with research backed and evidance- based curriculum around topics like STEM, financial literacy, healthy living, and more.

Please note you will be charged \$10 for every 15 minutes late for pick up of your girl starting at 5:31 PM for summer and 6:01 PM for afterschool.

DISCIPLINARY ACTION PROCEDURES

At Girls Inc., we strive to create a safe and fun learning environment for all of our members. In order to maintain this environment, we have a set of consequences in place for when a member's behavior is disruptive or harmful to others. We want to ensure that all members have the opportunity to learn and grow in a positive and supportive environment.

Our behavioral steps are structured as follows, but can be escalated up to immediate and permanent termination of a girl from the programs at the discretion of the leadership team:

Level 1 - Verbal Warning:

The first time a member's behavior is disruptive, we will give her a verbal warning. This is an opportunity for her to recognize that her behavior is unacceptable and to change it.

Level 2 - Reset:

If a member's behavior continues to be disruptive, we will ask her to take a reset moment. It is a chance for her to take a break, reflect on her behavior, and reset herself before returning to the group.

Level 3 - Sent to Front Desk:

If a member's behavior still continues to be disruptive, she will go to the front desk to address her behavior. This is an opportunity for her to speak with a staff member, who will help her to understand why her behavior is unacceptable and work with her to change it. The staff member will also determine an appropriate consequence for this behavior.

Level 4 - Sent to Management Staff:

If a member's behavior is severe or persistent, she will meet with a member of our leadership staff. They will determine an appropriate consequence based on the behavior, which may include a suspension or other disciplinary action.

Level 5 - Suspension:

If a member's behavior is extremely disruptive or harmful to others, she may face suspension from Girls Inc. This is a serious consequence and will be used in extreme cases, or when any physical altercation occurs.

Girls Inc. of Wayne County looks at the entire behavior/incident case-by-case: including the nature of the behavior/incident, and the context in which the behavior/ incident occurred. Each behavior/incident can lead up to further disciplinary action and/or termination.

CODE OF CONDUCT

Respect and Courtesy:

- Parents are expected to treat all program staff, volunteers, and other parents with respect and courtesy.
- Disagreements or concerns should be addressed in a calm and respectful manner, following the appropriate channels provided by the program.
- If you would like to schedule a 1:1 meeting, please email a leadership staff member.

Communication:

- Parents/Guardians will be informed about center closures, field trips, and program updates via Compass 360 messages.
- Inform the receptionist or leadership staff of any changes in contact information promptly.

Safety and Security:

- For the safety of your child, Girls Inc. of Wayne County will not release a child to any individual who is not listed in our database as an authorized pickup. Telephone authorization is accepted; however, an ID must be presented upon pick to match the person given permission.
- Parents must schedule an appointment to tour the facility, address concerns, or go beyond the designated pickup area, especially during programming hours.
- All personal items must be kept in a locker or backpack. Girls Inc. of Wayne County assumes no responsibility for the security of personal items brought to our centers.
- Please report any safety concerns or incidents to a leadership staff member immediately.

Parental Involvement:

• If a parent or guardian wishes to volunteer at Girls Inc. of Wayne County, they must schedule a meeting with the Director of Operations and complete a background check.

Compliance with Policies:

• Adhere to all policies and procedures outlined by the Family Handbook and additional communicated notifications

ADDITIONAL INFORMATION AND POLICIES

Abuse, Neglect, and Safety:

It is our duty to protect all children participating in these programs from physical and emotional harm or neglect. Girls Inc. of Wayne County strives to create a safe environment so that our members can grow, learn and have fun.

Part of creating a safe environment is making sure that our employees are aware and constantly vigilant about possible child abuse, neglect or safety concerns. All staff, including volunteers, will make every effort possible to prevent child abuse, and where abuse or suspected abuse has occurred, will take the necessary actions to protect the child in question from further abuse.

If any Girls Inc. staff member or volunteer identifies or suspects abuse, a report will be made, in collaboration with the leadership staff member present and after the Executive Director has been notified, to the Indiana Child Abuse/Neglect Hotline or law enforcement.

Staff are directed to not release a girl to an adult who they believe is under the influence of drugs or alcohol and law enforcement will be called. This includes the staff member smelling marijuana, alcohol, or observing concerning behavior of the adult picking the child up.

Lice Policy

We agree with health officials that head lice are not a health hazard because they do not transmit any disease. However, head lice is considered a nuisance and we take preventative efforts at the center. To avoid transmission of head lice, Girls Inc. conducts random head checks.

If signs of lice are identified, the caregiver/parents will be notified immediately to pick the girl up and to treat her. We will make every effort to preserve the dignity and privacy of each girl. As an additional preventative measure, we notify all families of live lice found at Girls Inc. and provide information on prevention and treatment. Re-admittance to the center will be allowed after documentation of a lice-free head check has been provided by Wayne County Department of Health, a school nurse, or doctor.

ADDITIONAL INFORMATION AND POLICIES

Health and Safety

Girls who have a fever, an active contagious infection, or who have vomited within 24 hours prior to coming to Girls Inc. should not attend for the day. If girls become injured or sick while they are at Girls Inc. we will contact parents/ guardians immediately, using the information provided on the girls registration form, to take them home and get treatment. If it is an emergency situation, we will contact emergency services as needed.

Cell Phones and Electronics

Girls Inc. of Wayne County has a strict, no cell phone or electronic devices policy for girls. This is for the safety of the girls, their devices, and the staff. Members are to be responsible for keeping all devices out of sight, at all times. This includes but is not limited to; cell phones, tablets and smart watches.

If a cell phone or any other device is being used, the girl will be asked to leave their device at the Front Desk until it is time to be picked up. If she refuses, a call to parents will be made and disciplinary action will be taken. If a girl is getting picked up, parents/guardians must follow our regular pick-up procedure and call the Front Desk or come into the center. Release of a girl will not be done through parents texting or calling the girl directly.

Network and Computer Acceptable Use

Girls Inc. of Wayne County has several electronic devices such as tablets and computers. Girls are expected to follow all rules such as:

- Only visiting/accessing safe and approved sites
- Not using the devices for personal matters
- Not visiting social media websites or chat options
- Not downloading any materials without permission

If rules are not followed, or devices are used inappropriately, discipline action will be taken, including up to termination from the program.

Illness

Girls who have a fever, an active contagious infection, or who have vomited within 24 hours prior to coming to Girls Inc. should not attend for the day. If girls become injured or sick while they are at Girls Inc. we will contact parents/ guardians immediately, using the information provided on the girls registration form, to take them home and get treatment. ADDITIONAL INFORMATION AND POLICIES

Field Trip Policies

We schedule a variety of exciting and enriching opportunities for the girls and provide prior notice for times when girls will be away from the Girls Inc. center. We expect girls will participate in these educational outings and remain with their group. Girls who arrive at the center when their group is on a field trip may not join the trip at the site and will be placed with an alternative group until their group returns. Girls may not be picked up from field trip locations for liability reasons. Parents and guardians are not allowed to chaperone field trips.

Snacks and Meals

Girls Inc. provides summer attendees with free breakfast, lunch and snacks. Meals are prepared in accordance with federal and state guidelines for nutrition. Families may choose to opt out of this program, however any girl bringing her own meal must pack food that is not temperature sensitive (does not need to be refrigerated or reheated). This restriction is due to the space and staff resources devoted to the summer food program.

If a girl has specific dietary needs or allergies, the parent/caregivers must notify leadership staff with advance notice so that an appropriate meal can be provided by our contracted food preparer. We will do everything in our power to accommodate needs and allergies but cannot accommodate preferences.

We request that families let us know when girls will not be participating in the free meals with us for the following week. Advance notification for prescheduled vacations is always appreciated.

Snacks are provided and vary every day. We work hard to accommodate allergies and dietary needs but cannot always guarantee an item. Please let staff know as soon as possible of an allergy/dietary need. Girls can bring their own snacks if they wish.

*Snacks are often received at Girls Inc. through donations by individuals and organizations and what we receive is outside of our control. If you wish to donate snacks for the girls, please let us know. We appreciate all donations.
